Presidents Report 2015

It is my pleasure to present this report although only taking on the role in November, so thank you for your support and encouragement in that time.

I firstly would like to acknowledge the time and effort put in by past President Paul Oxley over the last five years.

Most of the members recall the problems dating back eight or so years when our Club was struggling and in fact had major losses over a number of years prior to that.

Through various initiatives, due diligence, supportive Board and solid leadership from Brad the Bathurst Golf Club has sustained continual financial growth and with the help of Dave and his staff for course management, Matt Barrett's strong initiatives and approachable demeanor and with Brendan and his infectious positive outlook from behind the bar we can expect to maintain the growth and improve our Club.

The past year has seen a new Committee with a wealth of experience consolidate the clubs position with the Cart shed built and filled almost immediately, the dam on the tenth enlarged, the thirteenth Tee lifted, the top carpark sealed and a new Caterer Paul Coopes appointed.

Paul has taken on board a tough task, performed well and will continue to work closely with Brad and Brendan to showcase our Club as a fantastic venue with fine food.

The first full year of the Smart Solar panels has continually shown a saving above monthly estimates and Capital cost will be paid in four years – a great investment as will be an upgrade of the refrigeration system soon, supporting the Solar panel initiative.

Water is still our major cost and the Committees has had talks with Bathurst Regional Councils Mayor and Deputy Mayor in February with regard to reducing the cost of water and coming up with an average monthly rate to alleviate the spikes during the dry summer months.

A petition was circulated late last year to get members support to present to the Bathurst Regional Council – some 400 signatures were received- thankyou.

The meeting was well received and professionally presented by Brad and some Board members.

Another water initiative was looked at from a mining company and support for this is mixed in the Community and BRC are still to decide on the proposal.

Our course is as good as I can remember thanks to our dedicated Greens staff.

Changes as mentioned above, planning for improvements to the bunkers, fairway fertilizing, cart paths and general tidiness of the course is a credit to these guys and it is reflected in the daily positive comments received from all who play. Dave and his staff are to be congratulated on their passion- a credit to the Club and to Bathurst as the entrance to the City. Programming for our club is a mountainous task and getting the best mix and fit fall with Captain Manuel. To his credit has tried various formats and listened to member's comments and concerns and believe we have a good program mix but our ever changing membership demographic requires continual attention.

Our Vets involvement is very strong thanks to our Vice Captain Bob's dedication and commitment.

Our numbers for playing members both Female and Male has been stable for a number of years which goes against the trend in Australia and our Junior numbers are the highest ever – a big thanks to Matt and his efforts with the Schools and his general presence.

We will continue to work with the Ladies and their Committee to enhance their membership and to listen and act on their concerns.

The loss of Lisa our Bookkeeper for the past nine years has opened the door for Charlie and together with Brad will continue to maintain, support and improve our Club.

We thank Lisa for her valuable efforts in upgrading and setting financial systems for the Club, I would also like to thank Norm Matheson, Peter Sheppard and Trevor Dickie for their efforts on the board.

Looking to the future the Committee and management must continue to improve and advertise the attractiveness of the Club for indoor and outdoor Functions and to ensure that opportunities for membership are not restricted by cost and our Course will still be the best west of the Mountains and comparable to our City cousins.

It is with great pleasure that I present my annual 9th report for the Bathurst Golf Club year ending December 2015, in a year of ups and downs that included a change of restaurant mid-year the Club came home with a wet sail to post a profit of \$98273.00 which is a very pleasing result considering the multitude of projects that were completed in the year, more details of these are in the Director's reports.

I would like to thank Dave Rogers and his staff, Adam, Tom, Mick and Aaron for their efforts to present a fantastic golf course day in day out that is the envy of many in the Country. Brendan Bradshaw and his bar staff for the way they serve and entertain the members, Matt Barrett and his team for their courteous service to our members and guests as well as Paul Coopes and his team who have well and truly cemented their place in the Club. To Club Captain Manuel Pro and Vice-Captain Bob Pardey, I thank you for the devotion that both of you show in what has to be one of the highest workload positions in the Club! I would like to welcome Charlie Klein to her role as office administrator after taking over from nine year 'veteran' Lisa Koleda, a big thanks to you Lisa for all your hard work over these years.

A special thought for our 'little mate' Brendan 'Love' Dove who is currently in the fight of his life battling Cancer, our best wishes are with you.

At the time of writing the Club is in the process of exploring our options in regards to a cost effective and sustainable water supply which is our last 'great' hurdle in shoring up our future, we have been in discussion with our Council representatives on a fixed yearly cost for water which would enable us to budget for water expenditure during any given year, we are also embarking on the search for bores and looking at building new holding dams if the searches come to fruition, fingers crossed!

A particular focus now and in the immediate future is to develop our standing as a tourism destination for Bathurst, we have recently been the lead article in Inside Golf's 'The golfing gems of the Central West', featured on European golf tour writer Bernie McGuires 'Tourmiss' web-site and established a 'buddy club' relationship with the prestigious Lakes Golf Club in Sydney, in conjunction with Bathurst Regional Council we firmly believe the Bathurst Golf Club and Course can expand on it's already impressive tally of over 15000 yearly visitor rounds to the Club.

At the end of August myself and Brendan Bradshaw had the pleasure of the Club sending us to the Golf Managers Australia biennial conference on the Gold Coast, the experience was invaluable and we both gained a great insight into the golfing landscape Australia wide as well as learning a few things on the way! One of the most beneficial outcomes was the Club joining the GMA benchmarking tool, our subsequent information for 2014 has put us in the

top 25% of Club's Australia wide and we can now constantly keep an eye on how we are faring year to year against our competitors.

To our new President Ray Stapley it is a pleasure to work with a supportive chairman and a cohesive Board that can only help in our ongoing quest to be the premier golfing destination in the Central West.

Treasurers Report 2015

I take the opportunity to present the Financial Year Report, on behalf of the Board of Directors, for the year ending 31 December 2015.

Over the 2015 Financial Year our club recorded a very respectable net profit of \$98273.00 compared to a profit of \$75,503.38 (up 30%) for the preceding year.

The club has continued to maintain a steady growth (5.0%) across areas of revenue and the board and club management is continuing to strive in its endeavors to maintain and increase this improvement into the future.

Our total expenditure for the year has remained relatively static this year in comparison to the previous year at \$1,229,921.49 (up 3.7%), however, the Board has again undertaken a number of projects throughout the year working towards continuing to provide an improved and better facility for its members and guests. Some of the major expenditure experienced throughout the year include further improvements with the Pulse Golf Scoring System, additional cart shed, resurfacing of the top car park area, concreting the top carp park entry off Boundary Road, fencing course ground staff compound to improve security, Repairs and Maintenance to our aging infrastructure, continued improvement to the course (our pride and joy) and purchase of a new tractor for our hard working course staff.

Our investment in the solar panels continues to provide savings to the club with the estimated savings still exceeding the original estimates. The Board is continuing with its investigations into reducing costs further and we are currently considering several options with our water supply which is another significant cost to the club.

The Club continues to hold cash reserves of \$500,000 in investment, maintaining its position of financial security. Again I take this opportunity to remind you this investment would only maintain operations for three to four months should an unforeseen "event" occur.

The quality of the course continues to bring increasing numbers through our gates to play the game on our premier course. This along with the efforts of Brad our General Manager and his staff, our club professional Matt and his staff, promotion of the club for functions by our Bar Manger and Restaurant staff will continue to maintain the financial security of our assets into the future.

In closing, I would like to acknowledge the hard work of all staff involved in their various operations of the club throughout the year, and again encourage all members to continue to patronise the facilities of the club.

Captain's Report 2016

I may sound like a broken record but the following paragraph is the very same paragraph I have used to open my captain's report for the last few years. I don't see any reason to change it.

It has been another very good year for the Bathurst Golf Club, member participation in golf activities has increased and the club has consolidated its very sound financial position. Credit for this must be given to you, the club member, for the way you have supported all golfing activities during the year. All weekly competitions, Club Championships, Club Foursomes, the Bathurst Open and all major events were very well supported.

Because of your support the club has been able to consolidate its financial position for the eighth consecutive year and it all looks good for the future under the very capable management of Secretary Manager, Brad Constable supported by Charlie in the office,

Brendan behind the bar and all his staff.

Some of the credit for the way you have supported the club must also go to Club Superintendent, David Rogers and his staff for the way they have presented the golf course throughout the year and to Club Professional, Matt Barrett and his staff for the way they have looked after club members and visitors. Matt's dedication to the job and the way that he has promoted all golf activities at the club has been fantastic.

During 2015 we identified a number of major events that were no longer supported to the same level as in previous years namely; the Jimmy Johnson and Leeholme trophies. To encourage more participation changes were made from matchplay to stableford format. The changes worked and for the first time in a number of years we actually had reserved for this competitions.

However, there were also a number of members who were very loud in their disagreement of the change. With this in mind the board has decided to revert back to the matchplay format for these competitions. I sincerely hope that these members are the first ones to put their names down when the list for these competitions comes up again this year.

Another change that was introduced last year was in the C grade championships from stroke to stableford to encourage more players to participate. Once again the participation numbers increased but unfortunately the change created problems we had not foreseen and it became an administration nightmare. For this reason, this year's championships will be played in the stroke format.

I do foresee that in the not too distant future the C grade champion will be determined by stroke but the handicap champion will be determined by stableford format. I shall wait and see how this concept will be supported.

A project that we took on in 2015 was to use a variety of media to promote all golf activities. Our website www.bathurstgolf.com.au has kept members informed of club news, coming events and competitions results through the year. Local radio stations 2BS and BRock have kept members informed of competition results on a regular basis and the Western Advocate

has consistently printed a number of golf editorials each week. We sincerely thank these organizations for their support

Congratulations to all the major event winners and a big thank you to all who participated. A list of all major event winners can be found elsewhere in this Annual Report. Once again, the pennant sides performed very well and at the time of writing this report the division 3 pennant side captained by John Perfect will be playing in the final against Dubbo.

Unfortunately, the division 4 side narrowly lost their semifinal last week. We wish all the players all the best in the final play offs but regardless of what may happen we are very proud of the way that the players have represented the club.

Carrying out the Captain's duties with the support of Vice Captain, Bob Pardey was very easy going during the year. The very much appreciated help from Ian Farmer, on Thursdays and Ian Thomas whenever I am not available and Saturday's crew of David Lilly, John Young, Darren Smith, Darrell Bourke and all the other members that have sat at the scorer's table to give a hand during the year have made my job a very easy one. To all of you a very big thank you.

COURSE REPORT

During the spring and this summer our course has been in superb condition, I believe the best ever thanks to the efforts of David (course supervisor) 2IC Adam, Tom, Aaron and Mick. All members should be proud of our splendid course. This has come at some cost due to some very prolonged hot periods without significant falls of rain necessitating much heavier watering than normal. To enable the club to budget each year for water costs we recently had a meeting with Mayor Gary Rush and Deputy Ian North, and were given a good hearing and await a decision from council.

During the year a new 13th tee was constructed and has made this a feature hole giving a complete new look towards the green. Also as part of our ongoing bunker renovations the 2 front bunkers on 13 had changes to their shape and new drainage installed.

An overall bunker renovation program has been instigated and will commence this year with all 4 bunkers on 14 set to be rebuilt first. This will commence after the men's and women's championships. The right hand fairway bunkers on 17 have been filled in and will be grassed mounds in future. Our overall target is to have the sand texture consistent in all our bunkers.

In the middle of the year David and club professional Matt travelled to the Gold Coast to observe greenkeepers renovating bunkers with a new drainage treatment incorporating aggregate sealed with a porous surface however, David believes it would not be suitable for

Despite the many storms and wild winds during the year we lost a minimum of trees and large branches, unfortunately many come at the most inconvenient times. After these storms the fairways were well and truly covered with leaves etc; but were easily handled with our large blower.

The policy of updating our equipment continued with the purchase of a New Holland front end loader. The balance of equipment with the exception of the bunker rake (to be replaced this year) is in excellent order.

The cart path program will continue this year with 16-4 and 8th to receive work and the path adjacent to the 10th tee will be widened near the sand bin to allow carts coming from the 18th green to pass equipment and carts of players teeing off.

A bridge crossing the creek in front of the 8th tee was constructed and the old crossing which was an eyesore will have the turf established and the bare area with exposed tree roots between the 6th green and 8th tee will be turfed.

To ensure greater security of our course plant a man proof fence has been erected round the machinery shed allowing all equipment to be stored in a secure area.

Our multi skilled course staff laid the large concrete driveway for the Boundary road entrance to the top car park, a very professional job. Also during the year the top car park after the construction of the new cart shed was levelled off and surfaced with a crushed aggregate that after watering and rolling has given us a good hard surface.

Congratulations to Brad and the entire staff for bringing in yet another good result.
